DECRE E

NOW ON THIS DAY Comes on for hearing the matter of the formation of the Animas Mosquito Control District, the original Petitioners appearing by their attorneys, EMIGH AND EMIGH, and no other person appearing;

And from an examination of the records and files herein the Court finds:

1. That on July 28, 1960 pursuant to a Petition filed by more than one hundred (100) persons the Court ordered that a hearing concerning the formation of the Animas Mosquito Control District be held on September 2, 1960.
2. That due and proper notice of said hearing was given and said hearing was duly held on September 2, 1960. That at said hearing the Court found that said Petition was properly executed by the requisite number of taxpaying electors residing within the boundaries of said proposed District, and ordered that the question of organization of the District should be submitted to the taxpaying electors of the District at an election to be held for that purpose on September 27, 1960. That the Court further ordered that in connection with said election the Court appoint MYRNA AMBOLD, GERTRUDE B. FISHER and HELEN N. HURD, who are taxpaying electors residing within said proposed District, as Judges of said election. The Court further ordered that at said election the taxpaying electors should vote for five (5) Directors of the proposed District; the two (2) Directors receiving the most votes to serve as Directors of said District until the third biennial

election, the two (2) Directors receiving the next most votes to serve as such Directors until the second biennial election, and the Director receiving the next most votes to serve as Director until the first biennial election.

3. That due and proper notice of said election was given; that the same was held and properly conducted on September 27, 1960, and that the Judges heretofore appointed by the Court, who served as Judges of said election, have certified the results thereof to the Court. That the results of said election were as follows, to-wit:

The total number of votes cast for the organization of the District was 430.

The total number of votes cast against the organization of the District was 100.

The five (5) persons who received the highest number of votes were as follows:

Richard W. Repert	312
Cletus (Jim) Tysinger	285
Walter J. Osterhoudt	263
Al H. Haas	220
Dean Suttle	214.


NOW, THEREFORE, IT IS CONSIDERED, ORDERED, ADJUDGED AND DECREED by the Court that said Animas Mosquito Control District shall be and it hereby is established in accordance with the legal description of the outer boundaries of said District, copy of which is attached hereto and made a part hereof as Exhibit "A", and in accordance with the plat of the outer boundaries of said District, copy of which is attached hereto and made a part hereof as Exhibit "B."

It is further ordered that the following persons, upon filing their penal bond with corporate surety bonds in an amount not to exceed One Thousand and No/100 Dollars (\$1000.00) each, conditioned upon the faithful performance of their duties as Directors, and upon filing their oaths of office, both to be filed with the Clerk of this Court, shall be Directors of the Animas Mosquito Control District for the following terms, to-wit:

Richard W. Repert	Until third biennial election
Cletus (Jim) Tysinger	Until third biennial election
Walter J. Osterhoudt	Until second biennial election
Al H. Haas	Until second biennial election
Dean Suttle	Until first biennial election.
